GCSE and A level reform 2015

The UK Department for Education (DfE) and Ofqual have confirmed that there will be reforms to GCSE and A level qualifications in the UK and internationally. This means that new specifications for GCSE and A level qualifications in some subjects will be introduced for first teaching from September 2015.

We've put together this brochure to help you keep track of the reforms, so you can understand what the changes are and how they will affect you as teachers. We also want to tell you about the comprehensive support we are providing you with – not only now but throughout curriculum change and beyond.


There's still more detail to come from the DfE about the reforms and we will keep you informed about further developments as soon as we know what they are.

Edexcel GCSE and A level qualifications are regulated by Ofqual (Office of Qualifications and Examinations Regulation in England), and international schools that offer these revised qualifications will be following the same content and assessment approach as UK schools.

Take a look at the information enclosed. We hope it will provide you with a better understanding of what lies ahead for GCSEs and A levels.

What's changing?

GCSE reform

- ◆ New GCSEs in English Literature, English Language and Mathematics, for first teaching from September 2015 and first assessment in summer 2017.
- ◆ New GCSEs for first teaching from September 2016 are: Geography, History, Biology, Chemistry, Physics, Languages, Art and Design, Citizenship Studies, Computer Science, Design and Technology, Drama, Music, Physical Education and Religious Studies.

Features of the new GCSEs

- ◆ A new 1 – 9 grading scale with 9 being the top level. Grade 5 is proposed as a link to the international PISA tests and Grade 4 equivalent to the current C grade.
- ◆ A fully linear structure.
- ◆ Tiering will only be used for subjects where untiered papers will not allow students at the lower end of the ability range to demonstrate their knowledge and skills, or will not stretch the most able †.
- ◆ Exams will be the preferred method of assessment, except where they cannot provide valid assessment of the skills required ††.
- ◆ Exams in the summer term only.
- ◆ November resits for English Language and Mathematics only, for students who were at least 16 on the preceding 31st August.

† For tiered subjects the tiering model used will be confirmed by Ofqual on a subject-by-subject basis. So far, it has been decided that Maths and Science will be tiered.

†† Decisions on non-exam assessment will be confirmed by Ofqual on a subject-by-subject basis.





What's changing?

A level reform

- ◆ New A levels for first teaching from September 2015 and first assessment in summer 2017 are: English Language, English Literature, English Language and Literature, Physics, Chemistry, Biology, History, Psychology, Art and Design, Business, Economics, Sociology and Computer Science.
- ◆ Other subjects will be introduced for first teaching from September 2016. These are Geography, Languages, Drama and Theatre, Music, Physical Education and Religious Studies.
- ◆ A full list of subjects for first teaching from September 2017 will be available soon, but will include Design and Technology, Mathematics and Further Mathematics.

What will happen to AS?

- ◆ AS will be a standalone qualification for first teaching from September 2015.
- ◆ It will no longer contribute to the A level grade.
- ◆ Apart from Art and Design, AS qualifications will be exam only.
- ◆ New AS qualifications will be designed to offer breadth to the curriculum and will broadly remain at their current standard.
- ◆ In some subjects, it may be appropriate for the AS to be designed to be co-taught with the first year of the A level.

Timeline of GCSE qualification reform

GCSEs are being reformed in stages. Subjects in the **first stage** are English Language, English Literature and Mathematics. These subjects will be reformed for first teaching in September 2015.

Subjects in the **second stage** will be available for first teaching in September 2016. These are Biology, Chemistry, Physics, History, Geography, Languages, Art and Design, Citizenship Studies, Computer Science, Design and Technology, Drama, Music, Physical Education and Religious Studies.

Timeline of A level qualification reform

AS and A levels are being reformed in stages. Subjects in the first stage are English Language, English Literature, English Language and Literature, Biology, Chemistry, Physics, History, Psychology, Art and Design, Business, Economics, Economics and Business, Computer Science and Sociology. These subjects will be reformed for first teaching in September 2015.

Subjects in the second stage will be available for first teaching in September 2016. These are Languages, Geography, Drama, Music, Physical Education and Religious Studies. Subjects in the third stage will be available for first teaching in September 2017. These are Mathematics, Further Mathematics and Design and Technology.

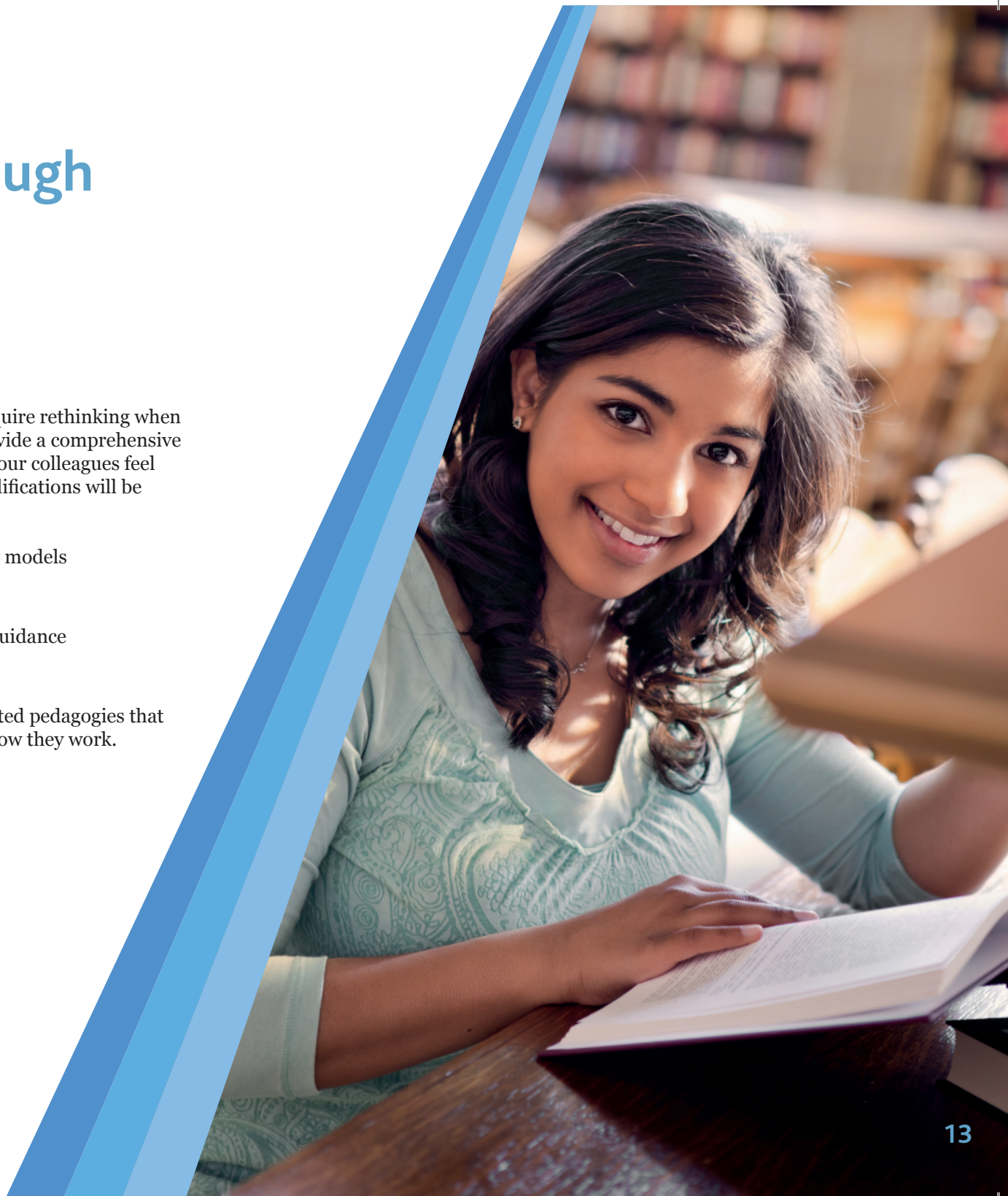
